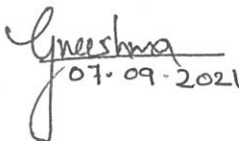

**CMDA deploys Special Team to clear pending planning permission applications in local bodies within Chennai Metropolitan Area.**
