Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby inform the resignation of Mrs. Neethu Subramoniyam (DIN:08788544) from the office of Independent Director with effect from 17<sup>th</sup> May 2024.

The Board took note of the resignation of Mrs. Neethu Subramoniyam (DIN:08788544) with effect from 17<sup>th</sup> May 2024 via passing circular resolution on 17.05.2024. It was also noted by the Nomination and Remuneration Committee via passing circular resolution on 17.05.2024. Consequently, she shall also cease to be a Member of the Audit Committee, Nomination and Remuneration Committee, Stakeholders Relationship Committee, Corporate Social Responsibility Committee and Risk Management Committee of the Company w.e.f., 17.05.2024 and also cease to be the Chairman of Nomination and Remuneration Committee.

In pursuance of the above-mentioned resignation of Independent Director, the Board, on the recommendation of the Nomination and Remuneration Committee via circulation (circular resolution was passed by the committee on 17.05.2024), considered and approved via passing circular resolution on 17.05.2024 to induct Ms. Mayuri Sinha (DIN:0008915515) as Additional Director (Non- Executive and Independent) and to designate as Independent Director for a period of two (2) years w.e.f., 17<sup>th</sup> May 2024 subject to the approval of shareholders within 3 months from the date of appointment or in the ensuing general meeting, whichever is earlier.
